The Hotlanta Rubber Group will use the 2009 Mr. Southeast Rubber (MSER) Contest to sponsor up to two representatives (Mr. Southeast Rubber and Mr. Hotlanta Rubber) to compete in the 13th Annual Mr. International Rubber (MIR) Contest to be held November 6-8, 2009 in Chicago, Illinois, in accordance with the rules and guidelines set forth in this MSER 2009 Contestant Application.

All proceeds raised by the Hotlanta Rubber Group during Mr. Southeast Rubber Weekend will go to *Positive Impact, Inc.* a 501-c3 organization registered with the federal government and the State of Georgia. Positive Impact's mission is to provide cultural and competent mental health and prevention services to individuals affected by HIV. So, being a contestant in the 2009 Mr. Southeast Rubber Contest is a great way to have a lot of fun with your rubber friends and raise money for a local charity at the same time.



For each contestant that competes in Mr. Southeast Rubber 2009, the Mr. Southeast Rubber Organizers will add \$25.00 to the total amount of money raised by the Hotlanta Rubber Group throughout the weekend. So, round-up your friends and let's have some fun!

Mr. Southeast Rubber 2009 Contestant Rules and Guidelines:

Each contestant:

1. Must be legally identified as male and be at least twenty-one (21) years old by the date of the contest.
2. Residency Requirements:
 - a) In order to hold the title of Mr. Southeast Rubber 2009 the winner must meet the following residency requirements: must be a legal resident of one of the following states: Alabama, Florida, Georgia, Mississippi, North Carolina, South Carolina, or Tennessee. Mr. Southeast Rubber 2009 does not have to be a member of the Hotlanta Rubber Group.
 - b) There are no residency requirements to hold the title of Mr. Hotlanta Rubber 2009. However, the winner of Mr. Hotlanta Rubber must be a current active member of the Hotlanta Rubber Group. Membership applications are available online at www.hotlantarubber.com. There are no annual membership dues for the Hotlanta Rubber Group.
3. There is no local, state or regional preliminary contest requirement for Mr. Southeast Rubber.
4. Must be self-identified as gay or bisexual.
5. Must be able to demonstrate to the judging panel an interest in the rubber/latex fetish.
6. Must agree to participate in all required contestant activities and judging categories.
7. Must agree to permit photographs to be taken of him at the MSER Contest for use on the Hotlanta Rubber Group website and/or related MSER publications and advertisements as deemed appropriate by the Hotlanta Rubber Group Coordinator.
8. Must agree to abide by the conditions set forth in the MSER Contestant Application.

The title winning contestant(s) expectations:

1. Although there are no official responsibilities attached to either title (Mr. Southeast Rubber and Mr. Hotlanta Rubber), the titleholders are expected to represent their local sponsors (if applicable) and the Hotlanta Rubber Group by competing in the 13th Annual Mr. International Rubber (MIR) Contest in Chicago, Illinois November 6-8, 2009. Because the Hotlanta Rubber Group does not maintain an active

travel fund, the titleholder(s) must agree to pay all personal MIR related travel expenses (including airfare, hotel, meals, ground transportation, and incidentals). However, travel related grants for MSER and MHR titleholders are available through the Lloyd E. Russell Foundation (<http://elrfoundation.org>). MSER Contest organizers will assist the 2009 titleholders in applying for these travel grants.

2. Titleholder(s) must agree to permit photographs to be taken of him at MIR for use on website and/or related publications and advertisements as deemed appropriate by MIR contest coordinators and staff.

3. Titleholders must agree to abide by the conditions set forth in the MIR application.

4. Mr. Southeast Rubber 2009 and Mr. Hotlanta Rubber 2009 will be invited to serve as judges at the 2010 MSER contest expected to be held in August 2010.

Contest Overview and Judging Guidelines

Mr. Southeast Rubber contestants will be scored by a panel of five judges representing leaders in the rubber/leather/BDSM fetish community, as well as Hotlanta Rubber Group general members and contest attendee's in the appropriate categories. Judging is comprised of 4 categories using the scoring criteria listed below:

1. **“Slick Him Up” Meet and Greet (Friday Night) – maximum of 200 points.** The “Slick Him Up” Meet and Greet is designed to see how well contestants can use their charm, personality, and a bottle of silicone lube to interact “in gear” with a group of fun-loving rubber/latex enthusiasts and Atlanta Eagle patrons. Each contestant must remain in his selected rubber/latex gear at all times with at least 25% of his body continuously covered in rubber/latex/neoprene, etc. Contestants must adhere to all state and local laws and ordinances pertaining to nudity and obscenity, ensuring that their genitals and anus remain covered at all times. By city ordinance, each contestant must have their anus cover by a strip of material measuring at least one inch in width. Each contest attendee will be given a numbered ballot for each beverage or jello shooter purchased. Each ballot will enable the attendee to vote for contestant(s) of their choice. Each vote received will count 1 point. Each point received will count toward the contestants overall score up to a maximum of 200 points, so work the room boys! The voting portion of the “Slick Him Up” Meet and Greet will last until 1:00am.

2. **Panel Interview (Saturday Afternoon) – 40 points per judge.** Each contestant will meet with the panel of judges in a “closed interview” to answer questions about the contestant’s personal and sexual history, interest and knowledge in rubber/latex, BDSM and related fetishes, as well as their willingness and ability to represent the title of Mr. Southeast Rubber or Mr. Hotlanta Rubber at MIR. Interviews will last an average of 10 minutes. Contestants will be judged on (a) the rubber gear they have chosen to wear to the interview in order to portray their own rubber image, (b) poise and personality during the interview, (d) ability to communicate effectively with the judges and (d) over all willingness and ability to represent the title.

3. **Rubber Image (Saturday Night) – 40 points per judge.** Each contestant will be introduced to the audience and judges using the information provided on the application. Following the introduction, each contestant will be asked to respond to at least two of the following questions:

- a) If you were given a gift certificate to buy any piece of rubber gear you wanted, what would it be and why.
- b) What stimulates you (mentally and physically) most about rubber/latex?
- c) What super hero would you most like to slick up in full rubber gear and what then would you do with him?
- d) What one piece of advice would you give to a friend who is about ready to have his first sensual/sexual rubber experience?
- e) How did you first discover the rubber fetish/lifestyle and what made you want to experience and learn more about it.

Contestants will be judged on (a) how relaxed and comfortable they are in front of the audience, (b) ability to communicate effectively and hold the attention of the audience, and (c) how well they respond to the questions.

4. **Liquid Latex (Saturday Night) – 40 points per judge.** Each contestant will be given a pint of liquid latex and a variety of sponge brushes. Contestants can choose to supply their own smooth demo model or have one assigned to them by MSER staff. Each contestant will have a specified amount of time to apply the liquid latex to their demo model and/or to themselves in an artistic and creative way. While the contestant is applying the liquid latex, their written rubber fantasy will be read to the judges and audience by the MC. Judging in this category is based on (a) how well each contestant presents themselves on stage, (b) how well the contestant portrays the sexual and sensual nature of rubber/latex in their written fantasy, and (c) overall creativity in their liquid latex creation.

Title Winners:

The contestant whose overall aggregate score is the highest and meets the residency requirements will become the Mr. Southeast Rubber 2009 titleholder.

The highest scoring Hotlanta Rubber Group current active member not awarded the title of Mr. Southeast Rubber will be awarded the title of Mr. Hotlanta Rubber 2009.

In the event of a tie, the “Slick Him Up” points will be removed from the aggregate total, then highest scoring contestant will be declared the winner. If a tie still remains following the removal of the “Slick-Him-Up” points, the judges and organizers of the Mr. Southeast Rubber Contest reserve the right to make the final determination of the winner(s).

Mr. Southeast Rubber 2009 is expected to compete in the 2010 Mr. International Rubber Contest. Mr. Hotlanta Rubber 2009 is strongly encouraged to compete in the 2010 Mr. International Rubber Contest.

Other Significant Information:

Contestants, assistants, judges and event organizers must wear their Official MSER badges at all times during the two day contest.

Each contestant is permitted to have two male assistants in the dressing area to help him prepare for the Saturday Night Contest. The assisting persons must be male and must obtain a badge in order to enter the dressing area.

Contestants are strictly prohibited from having any form of private meeting or engage in any sexual activity or play sessions/scenes with the contest judges and organizers from Friday at 9pm until 10pm on Saturday. Following the announcement of the 2009 titleholder(s) go for it! Any violation of this policy whether accidental or intentional will result in contestant disqualification.
